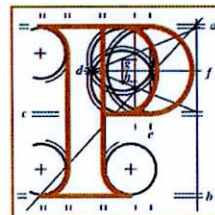

Finally, in relation to your reference to an Inspector's report on this case dated 20th May, 2020, I am not aware of any such report and I would also point out that this particular application was received by the Board in May 2021 (as referenced above). As a general point, I would also advise that an Inspector's report is never available until after the Board has made a decision on a case, so your request can not be acceded to in any event.


