

Following representations from numerous constituents, we, the above noted Councillors wish to make a submission to An Bord Pleanála in relation to the proposed upgrade and improvement works at Thomastown and Fantstown.

Thomastown

Our comments in relation to the proposals at Thomastown, Kilmallock Railway Crossing relate to the serious grounds of Health and Safety for all road users as follows:

We request that a double lane road over the railway be accommodated for all vehicular traffic and for accessing and exiting the junction in a safe manner. This should also incorporate 'stacking lanes' from both directions on the Main Charleville - Kilmallock road in the interests of further road safety as a result of the ongoing huge volume and consistent speed of traffic.

Fantstown

Our comments in relation to the Fantstown proposals are as follows:

The proposals as currently set out will split the parish of Bulgaden Martinstown and divide the community and access to Staker Wallace New GAA Grounds. It is a very popular loop walk and necessary for landowners on both sides and residents who have used this for generations. Lands need to be accessible for pedestrians and vehicles. We would be grateful if the new proposals as presented by Iarnród Éireann here can be reconsidered.

Conclusion

We respectfully request that the observations made will be given due consideration and will be reviewed by An Bord Pleanála.
